What does MCCA do for you? You've come to the right place to find out! This annual report is full of information about the activities and accomplishments of the Board of Directors, standing committees, membership services committees, regional branches, and employees.

We are pleased to advise we have made steady progress in the four main goals identified in our strategic plan 2007 – 2010. As always, some goals are easily accomplished and others take more time, resources, or planning before they can be implemented or crossed off the list. However, the main thing is we are alert, active, achieving, seeing progress, and sticking to it!

<u>Goal</u>: To communicate with all members so they are aware of what MCCA does.

<u>Objectives</u>: Identify and evaluate current communication techniques in Winnipeg and rural Manitoba; to implement strategies to improve communication; to explore new technological avenues

Progress:

- contracted with Viewpoints Research to evaluate our communication techniques in Winnipeg and used the findings to implement improvements
- · updated our inquiry and new member packages
- revised our information brochure
- added our mission statement and new vision statement to each issue of Child Care Bridges
- continued quarterly telephone meetings with regional branch chairpersons
- held semi-annual meetings with leaders of the directors support groups
- MCCA staff and members of the Board of Directors attend committee meetings, public events, and community activities
- continued toll free telephone number for rural members
- held several group teleconference calls for members on specific topics
- conducted online membership surveys to gather member opinions
- continued to expand use of email and build our website
- purchased Workbench software to improve membership database and event registrations

- library inventory posted on our website and information about new resources emailed to centres and family child care providers
- a report on our activities and services is included in each issue of Child Care Bridges, the Annual Report, and on our website

<u>Goal</u>: To offer a wide range of professional development opportunities across Manitoba.

<u>Objectives</u>: To explore and implement different ways of providing professional development outside Winnipeg; to explore and implement different ways of providing professional development to the regions; continue to deliver high quality, relevant training

Progress:

- close to 60 professional development workshops were available for members with accessibility to Winnipeg
- travel subsidy available for rural members to attend annual provincial conference
- financial rebate given to 6 regional branches to help with costs of workshop development for rural members
- 9th annual Directors Conference held in Interlake Region
- Managing & Leading in the Non-Profit child care sector held November 2008
- helped organize the Handle With Care training project
- conducted an online survey of rural members to identify their interests and opinions and preferences for professional development
- met with Manitoba Child Care Program representatives to identify priority areas for professional development
- donated web space to regional branches to promote local professional development events in rural areas
- provided telephone support to help regional branches identify workshop facilitators, prepare contracts, etc.
- provided many ways for members to socialize and have fun, such as during the Week of the Early Childhood Educator or paddling with Three Hour Tour
- provided our family child care provider members with an activity and record keeping resource calendar
- held a training program for rural and Winnipeg members to become ethics guides

- held many meetings with and wrote many letters to provincial and federal government officials
- submitted recommendations to the Government of Manitoba and opposition parties
- provided information bulletins to members during federal election
- represented members at town hall meetings during federal election
- submitted a brief to the House of Commons Standing Committee on Finance
- represented members at provincial pre-budget consultation meetings
- communicated regularly with Manitoba Child Care Program

- participated on the Child Care Regulatory Review Committee
- revised and distributed the Market Competitive Salary Guideline Scale for Group Child Centres, 2008
- organized a "Call to Action" to draw attention to the childcare workforce shortage in Manitoba
- participate with stakeholder groups such as Campaign 2000, Healthy Child Manitoba, Child Care Inclusion Committee

For the first time in 31 years, MCCA conducted a thorough and objective independent review of our group benefits plan in 2008. Treasurer's Report Brenda McCarthy

MCCA continues to be a strong non-profit organization with the most members than any other provincial child care association in Canada. We are 3,629 members strong (3510 in 2007). For this reason and sound fiscal management, MCCA remains in good financial standing.

We finished the 2008 year off with a reasonable (un-audited) surplus of \$22,400 which will be divided between our three fund accounts; Building, Project and Insurance. Revenue is made up of 58% of Membership fees, 35% of Membership Services (conferences, workshops and various other projects) and other misc. Revenue (interest and Resource sales, etc).

Expenses this year aside from normal operating expenses were the upgrade of two computers, upgrade of the photocopier, conducted a membership survey as a follow-up from the last strategic planning session and the purchase of a new membership program called Workbench. It is important to note at this time that the membership fees for MCCA have not increased since 2000. The last two increases to fees, of which the most recent was in January 2009, are paid to the Canadian Child Care Federation for your affiliate membership.

Your fees allow MCCA to be the leader in advocacy, provide high-quality conferences and workshops, maintain a top of the line resource library and continue to link together (in various ways) our child care field. I am proud to be a member of MCCA and hope you are too!

I would like to thank the Finance Committee members and staff for committing their time and hard work to MCCA.

The mandate of this committee is to ensure MCCA maintains a diverse, well skilled board. It also ensures that operational procedures are developed in order to achieve our vision and mission.

In 2008, the committee developed a mandate for a Membership Survey 2008 Working Group and struck up a committee which consisted of three members from Board Operations and Development and three members from the Child Care Benefits Committee. This committee worked with Viewpoints Research to develop a membership survey which polled 300 MCCA members.

The committee reviewed policies, creating some new ones and amending others throughout the year. The committee also secured a slate of nominees for the 2008/2009 Board of Directors.

The past year has been a very busy year for our committee. Members participated in a review of our group insurance plan and agents which resulted in a change of providers. We are pleased to be moving forward with an upgraded plan at a reduced cost as a result of the extensive plan review. Our members have always had a choice in the providers of a group insurance plan and through the review we learned that less than half of our members were taking part in the former program. Our new agents and company, Health Source Plus, offer dynamic and useful wellness programs and innovations which we are confident our members will employ to ensure those members and their families are healthier. We know that the provision of a high quality group insurance program is one of the top reasons that people we recruit to work in our programs desire, so we looked for plan and team of professionals that would be seen as part of a total compensation package for our membership. We looked for a company who would market the plan to the members throughout the whole province, provided all services in both English and French and could provide services to members including Family Child Care Providers. The use of web-based technology to administer the plan will allow centres to manage the plan independently as well as the ability to have assistance by a competent, professional staff over the phone.

The Child Care Benefits Committee and Board of Directors combined their efforts to share the work of the review process. At the end of the review process a number of members decided to leave the committee as they were unhappy with the decision to change companies. The Board of Directors ratified the committee's decision to change agents and providers of the group insurance plan. Thank you to everyone who worked diligently over the past year to ensure that we continue to provide quality service programs for our members.

This committee will work consistently with Health Source Plus and make adaptations to the plan in a timely manner ensuring that cost containment measures can be controlled over time to ensure that we are getting the best service at a reasonable cost. The committee will also continue to ensure that all of the insurance programs offered by the Manitoba Child Care Association are of high quality and responsive to the unique, growing and changing needs of our membership.



To date, hundreds of CCAs and ECEs have participated in the *Best Choices: The Ethical Journey* workshop series, as well as the follow-up workshop, *Beyond Part IV*. Demand for the workshops continues to be high in all regions.

In May, potential guides participated in a four day Ethics Guide training session. "Seasoned" guides helped participants deepen their understanding of their personal belief systems, the MCCA Code of Ethics, a framework for ethical decision making, the Best Choices curriculum and facilitation strategies. Additionally, two other guides were practicing their emerging roles as senior mentors on the committee and learning some of the strategies for training ethics guides. This is the committee's way of succession planning for the work of the Ethics Committee. Ten new guides joined the committee! Our

The Public Policy and Professionalism Committee has had a very busy year. The year began with a meeting with Minister of Family Services & Housing, The Hon. Gord Mackintosh to discuss MCCA'S 2008-2009 recommendations for Early Learning and Child Care in Manitoba. Following this, meetings were held with the NDP Caucus and then the Liberal Caucus summarizing our most urgent challenges. Members were provided with the same recommendations as were presented to the

minister as well as a copy of the Market Competitive Salary Scale for Group Child Care Centres. There were many letters, messages and emails distributed, hoping to influence the spring budget. The message was simple and clear that we needed an overall funding increase of 20-25% for the childcare workforce to catch up to other sectors that require similar knowledge, skills, and abilities.

Michael Ignatieff, representative of the Liberal Party of Canada, met with the committee members in May so once again we told our stories, shared our concerns and dreams for a better future. Exciting times were ahead for the committee as the Market Competitive Salary Guideline Scale for Child Care Centres over 100 spaces was reviewed prior to distribution. Another federal election was held, and MCCA participated by letter writing, preparing information resources for voters, attending election forums, and communicating with candidates.

The Committee, along with the Leaders of Director's Support Groups welcomed and met with the Lois Speirs the Acting Director of the Manitoba Child Care Program. The committee shared with her the support for and the need for the implementation of the Market Competitive Salary Scale 2008 that was released by the MCCA in the fall.

The Committee enjoyed a very successful Call to Action October 22, 2008 in which Director's and staff were invited from Winnipeg and the rural communities to come to the legislative building to sign up for a stronger workforce. Many Director's and parents shared their stories of the day to day frustrations they experience because of the staff shortage, wages that aren't competitive, shortage of child care spaces, other concerns related to the child care industry. The Minister was not able to attend the event but agreed to meet with the committee and child care reps from the community in the future.

All in all we had a very busy, challenging year and we are sure that 2009 will be the same.



Plans for future activities:

The committee will remain in contact with the government to ensure they are informed of MCCA's recommendations. We hope to encourage the government to expand the system in tandem with the availability of the workforce. We will continue to put pressure on the government to provide sufficient funding so that all centre's can follow the most current Market Competitive Salary Guideline Scale and that licensed family child care providers earn competitive wages. We would like to work with the province in educating the public to raise respect for ECE's as well as the early learning field as a whole.

Thank you to the committee member's for your time, dedication and valuable insight and visions for the early learning and child care field and all who work in it.
