

## **Privacy Project Documentation License Agreement**

### **Binding Nature of this License Agreement**

PLEASE READ THIS LICENSE AGREEMENT CAREFULLY. YOU CAN ONLY USE THE PRIVACY PROJECT DOCUMENTATION IF YOU AGREE TO BE BOUND BY THIS LICENSE AGREEMENT. AS A RESULT:

- (a) YOU DO NOT NEED TO SIGN THIS LICENSE AGREEMENT TO BE BOUND BY IT. IF YOU USE ANY OF THE PRIVACY PROJECT DOCUMENTATION IN YOUR PRIVACY PROJECT OR IF YOU COPY ANY OF THE PRIVACY PROJECT DOCUMENTATION, THAT USE OR THAT COPYING WILL MEAN THAT YOU HAVE AGREED TO BE BOUND BY THIS LICENSE AGREEMENT.
- (b) IF YOU DO NOT WISH TO BE BOUND BY THIS LICENSE AGREEMENT, PLEASE IMMEDIATELY RETURN THE PRIVACY PROJECT DOCUMENTATION TO MANITOBA CHILD CARE ASSOCIATION ("**MCCA**") (AT YOUR COST). UPON ITS RECEIPT OF PRIVACY PROJECT DOCUMENTATION IN RE-DISTRIBUTABLE CONDITION FROM YOU, MCCA WILL REFUND ONE-HALF OF ANY LICENSE FEE THAT YOU HAVE PAID TO IT. YOU MUST NOT RETAIN ANY COPY OF ANY OF THE PRIVACY PROJECT DOCUMENTATION THAT YOU HAVE RETURNED TO MCCA.

Personal Information Protection Agreement (for use when disclosing personal information to a third party)

(collectively, the "**Privacy Project Documentation**"), which MCCA may in turn provide to other organizations or individuals.

2. Aikins claims copyright in all of the Privacy Project Documentation.
3. Aikins has invested significant time, effort and expense in developing the Privacy Project Documentation.
4. MCCA has also invested significant time, effort and expense in developing the Privacy Project Documentation, which it hopes to recoup by charging a license fee to organizations and individuals to whom it provides copies of the Privacy Project Documentation.
5. Any organization or individual who receives any Privacy Project Documentation from MCCA is referred to below as "**you**".
6. Any reference below to "**copy**", "**copies**" or "**copying**" includes both hard copies and electronic copies.
7. When you receive Privacy Project Documentation from MCCA, this License Agreement will be included.

### **Grant of License to Use the Privacy Project Documentation in Your Privacy Project**

Aikins hereby grants to you a license to use the Privacy Project Documentation in your privacy project, and you hereby accept this license, subject to the followings terms and conditions:

- (a) you may only use the Privacy Project Documentation in your privacy project;
- (b) you may make as many copies of the Privacy Project Documentation as you require for purposes of your privacy project, so long as the Aikins copyright notice appears on every copy;
- (c) you may not provide any of the Privacy Project Documentation or any copy thereof to any other individual or organization for use in their or anyone else's privacy project;
- (d) you are responsible to make sure that the terms and conditions of this License Agreement are honoured by your directors, officers, employees, independent contractors and/or volunteers;
- (e) MCCA shall be entitled to advise Aikins if it becomes aware of any breach of this License Agreement by you;

- (f) this License Agreement shall be deemed to automatically terminate in the event of any breach of this License Agreement by you (in which event you must immediately stop making any use of the Privacy Project Documentation); and
- (g) this License Agreement shall be governed by and interpreted in accordance with the laws in force in the Province of Manitoba.

For greater certainty, as used above, "*your privacy project*" is confined to the specific privacy project for the specific legal entity that has agreed to be bound by this License Agreement, and does not extend to any other privacy project for any other legal entity.
