### About The Manitoba Child Care Association (MCCA)

MCCA is a voluntary professional association for the early learning and child care workforce in Manitoba. We work to further early learning and child care as a profession and promote the advantages of a public investment in developing a system of high quality accessible and affordable child care services. With close to 4000 members, MCCA is proud to be the largest and most successful provincial child care organization in Canada.

MCCA was established in 1974, is a registered charity, and operates as a not for profit organization. We are entirely membership funded and grateful to have the support of the child care workforce in Manitoba.

### What are the benefits of an MCCA membership?

An MCCA membership can help you succeed. It is an investment in your credibility as a professional, and in your personal career development. An MCCA membership provides you an opportunity to participate in events that allow you to learn, connect with your peers, share ideas, and find information. ### What does MCCA provide for you?

MCCA provides you with resource information through our publication *Child Care Bridges*, and through the CCCF publication *Interaction*. We have a resource library you can visit in person, or we will mail to you resources from our library to help with curriculum planning, or a DVD for your next staff meeting.

Manitoba Best Practices Licensing Manual for Early Learning and Child Care Centres recommends 24 hours of professional development per year for Early Childhood Educators and Child Care Assistants. MCCA offers professional development workshops and annual conferences that members can attend at reduced rates. Members located outside of Winnipeg can attend workshops

offered by our regional branches. MCCA members located outside of Winnipeg may be eligible for travel subsidy to attend our provincial conference. Details are in the conference programme.

Our large membership base enables us to negotiate lower group rates for programs such as:

- group benefits plan, which includes life, disability, health, dental, and vision care
- group RRSP and a registered pension plan
- liability insurance

We offer a job board for centre members seeking employees or those seeking employment, recognition awards for members achieving excellence in their workplace, opportunities to meet new people and have fun at recreational events.

Members keen to be active, involved, and enhance their own leadership skills can become an MCCA volunteer on various committees, special interest groups, or stand for election to our board of directors.

If you want to learn more about early learning and child care and be part of a strong, vibrant community of educators, joining MCCA is a step in the right direction

## What else does MCCA do?

Child care as a public service and as a profession has evolved because of the advocacy work of the Manitoba Child Care Association. As the voice of early learning and child care in Manitoba we use the thrust of our substantial membership to strengthen the profession, expand services, and improve quality.

While our lobby success stories may not be visible to our members on a day to day basis, our efforts has contributed to better compensation, the government supported pension plan and retirement benefits, capital funding to eligible child care centres, ongoing increases to operating grants, and tuition support and workplace training for ECE students, to name a few.

If you are the director of a full or part time child care centre, you will find additional information in the Executive Directors Guide. It is available on our website.

## What does an MCCA membership cost?

Some child care centres pay for their employees MCCA membership as an additional benefit. Others remit to MCCA the dues paid by their employees on payroll deduction. Individuals can also pay independent of their employer, either in full for the year by cheque, cash, credit card, or monthly by pre-authorized debit.

Individuals (payable annually, or monthly by payroll remittance or EFT):

Full time ECE: \$17.34/month      Part time ECE: \$10.34/month  
Full time CCA: \$ 9.34/month      Part time CCA: \$ 6.34/month

Associate: \$116.00 annual or \$9.67 per month  
Student: \$ 10.00 (MCCA only) annual  
\$ 35.00 (MCCA and CCCF) annual

Rates for Child Care Facilities are:

Full time Child Care Centre: \$210.00      Part Time Child Care Centre: \$112.50  
Family Child Care Provider \$150.00 annual      Family Child Care Provider: \$12.50 per month

MCCA membership year is January – December. Visit our website for details. Annual receipts are mailed to active members annually in February. All membership categories (excluding the \$10.00 student membership) include a joint affiliate membership with the Canadian Child Care Federation.

## How do I become a member?

Complete an Individual Membership Application. You can print one from our website [www.mccahouse.org](http://www.mccahouse.org). Most child care centres also have a supply of application forms. Choose your payment option and submit the application with your fees (if you are not on payroll remittance). Annual fees can be pro-rated for the number of months remaining in our membership year.
