## EXECUTIVE DIRECTOR'S & PRESIDENT'S REPORT

Tracy Cosser, President & Jodie Kehl, Executive Director

This annual report summarizes some of the activities, issues, opportunities, and challenges of MCCA in 2019 that kept our board, staff and volunteers very busy.

We continued to use our strategic plan to guide the work of the association, focusing on increasing membership, advocating for quality child care, collaborating with the education system and improving access to professional development to all our members.

Despite the lack of funding increases to existing not for profit programs (centres), Early Learning & Child Care (in Manitoba) received a significant amount of attention in 2019. The general petition which garnered over 26,000 signatures in four short weeks, was considered unprecedented by many. Members of the Legislative Assembly could not recall a previous petition to have such momentum. With both a provincial and federal election occurring in 2019, MCCA worked tirelessly to ensure child care was identified priority. During the last weeks of the provincial electoral campaign, early learning and child care received much media attention which further perpetuated the petition's significant success.

MCCA continued to meet with the Early Learning & Child Care Program staff and Minister(s) throughout the year. Unfortunately, 2019 did not result in an increase to centres and the financial challenges continue to increase.

#### 2019 - A Year at a Glance

**January:** MCCA attended (one of) the Canada-Manitoba Early Learning and Child Care Agreement Sector Consultations. Numerous sessions were held across the province from January to October. These sessions were an opportunity for stakeholders to offer feedback on Manitoba's Action Plan.

**February:** MCCA circulated a general petition to increase funding for licensed not for profit child care programs beginning February 22. It remained in circulation for four weeks.

Jodie Kehl, Executive Director, represented MCCA at an Early Learning and Child Care Data and Research Conference in Ottawa at the end of February.

**March:** The petition circulated until March 22. Over 26,000 signatures were received.

The Provincial budget was announced on March 7, 2019. In addition to several requests, MCCA called for an immediate increase to operating funding to licensed child care facilities which had been frozen since January 2016.

**April:** at the beginning of April, MCCA presented the Manitoba Legislative Assembly with its petition. It was read every day in Question Period for months afterwards to remind the provincial government of the need for consistent and adequate investment. We celebrated the 28th annual Week of the Early Childhood Educator during the week of April 2 – May 4, 2019 with a scavenger hunt and bowling. MCCA applauded its 121 volunteers for all their hard work, dedication and commitment.

MCCA had the opportunity to attend and present at ECEBC's Annual Conference, Looking Back, Moving Forward in Vancouver, BC. In addition, Jodie represented the MCCA membership at the CCCF Affiliate Meeting.

**May:** MCCA presented a submission to the K-12 Education Commission Review and attended an Education Commission Public Forum on May 15th.

MCCA's 42nd conference, Explore *Dream* Discover, was held May 23-24. Thursday's keynote speaker was the insightful Holly Elissa Bruno. On Friday, we shared many laughs with Dr. Paul McGhee.

**June:** MCCA was an invited speaker to a Town Hall on early learning & child care, planned by Member of Parliament, Daniel Blaikie.

**July:** Summer issue of *Child Care Bridges* published and MCCA celebrated its 45th Anniversary!

MCCA's Public Policy & Professionalism committee created questions for the candidates running in the provincial election. All candidates were asked about a comprehensive provincial strategy, which addressed affordability, accessibility and quality. The Province announced a request for proposal of a child care funding model review.

**August:** This month was all about **#support26K**. With an imminent provincial election, MCCA propelled support from the general petition and held a rally/walk at Assiniboine Park on a beautiful summer evening. Over 2200 participants attended.

Representatives from the four main parties joined the group to share their campaign promises to the sector.

As the parties respond to the candidate questions, MCCA posts on all social media as a means of educating its members on the party positions.

**September:** We celebrated the 20th Annual Directors Conference, *Culture of Caring*, in Gimli, Manitoba with 134 attendees. An inspiring time was had by all.

The provincial election was held on September 10th. MCCA was asked to be a part of the coverage on both CTV and CBC for election night! This was one of the first times that child care was a part of the electoral talk along with health care, poverty, education and business. What a great honour!

MCCA reduced student memberships to only \$10/year to help make things more affordable for ECE students.

MCCA becomes a member of the Manitoba Chamber of Commerce.

**October:** MCCA held its 3rd Pedagogical Institute, *Pedagogy in Motion: From the Ordinary to the Extraordinary Educators as Researchers*; there were 472 participants for the wine and cheese and 191 in attendance for the full institute.

We continued to offer support and a meeting place to the Leaders of the Directors Support Groups.

We also hosted the first Directors of Large/Multi-site Centres networking meeting.

The Federal Election was held on October 21st.

2020 marked the 30th Anniversary of the Day of Demonstration at the Legislature.

**November:** MCCA completed the 12th annual Market Competitive Salary Guideline Scale for 2019 – 2020.

Jodie Kehl and Tracy Cosser (MCCA's President) attended the Throne Speech at the Legislative Assembly on November 19th.

**December:** The inaugural Minister's Consultation Table meeting was held on December 3rd. MCCA is one of 12 individuals which holds a seat; the purpose of this table is to support the ongoing evolution and development of Manitoba's Action Plan in the Canada-MB Early Learning & Child Care Agreement.

MCCA represented its members in Ottawa for a national ELCC meeting on December 5th. This meeting brought together the cross-Canada network of leaders from the child care sector, social justice and feminist groups, policy experts and national unions to discuss the current state of child care across the country.

The printing of Chapter 16 (HR Management Guide) on *Succession Management Planning* was completed.

MCCA takes pride in being the largest provincial child care organization in Canada and an affiliate of the Canadian Child Care Federation.

In 2019, MCCA continued to use social media as a means of promoting its work and connecting with its membership. By the end of the year, MCCA had over 1700 followers on Facebook.

Over 50% of MCCA's operating revenue is derived from membership dues. Because of our committed members, we are able to consistently advocate for a quality early learning and child care system in Manitoba. We will continue to meet with policy makers reminding them of the crucial importance of investing proportionately and fully into the system so that it can continue to grow while supporting the workforce.

Thank you to the MCCA Board of Directors, all committee and regional branch volunteers and of course the MCCA staff.

Together, we are stronger.

## TREASURER'S REPORT

Another fiscal year has come to its close so we reflect on the past years activities for MCCA. As of December 31, 2019 MCCA realized an unaudited surplus of \$93,590. MCCA will allocate this surplus across the following fund accounts: Building, Insurance and Project; which are for future projects.

With a current membership of 4,109 strong, MCCA continued to be your leader in advocacy (remember the #support26K campaign), provide high-quality conferences and workshops, maintain a top of the line resource library and continue to link together (in various ways) the child care field. Without your fees, MCCA would not be able to achieve any of these goals. I don't know about you but I am very proud to be a member of MCCA!

#### Revenue

Membership fees represents 55% of revenue with an increase of \$9,158. from the prior year.

Membership Services represents 42% of revenue with an overall increase of \$45,884.

Some noteworthy revenue:

- The Online Board Governance netted a surplus of \$18,666.
- The Pedagogical Institute netted a surplus of \$12,856.
- In 2019 the annual provincial conference moved to a 2 day event and resulted in a netted a surplus of \$59,468.
- MCCA received our rebate from the Victoria Inn in the amount of \$7,900. which represents 5% of the food expense spent at the hotel over a 3 year time period.

Other revenue 2.3% - which includes: promotional items, donations, interest, Bridges advertising, etc. Resource Sales decreased this fiscal year as there was a large order of Human Resource Management Guides in 2018.


#### Expenses

Salaries Expense decreased this year by \$10,909 due to the overlap of two Executive Directors for a short time in 2019. Board Discretionary Funds decreased in 2019 from 2018 due to Pat Wege's retirement party. The big advocacy project in 2019, netted an overall expense of approximately \$8,800. Most other expenses were on par with prior years.

MCCA continues to use the accounting services of Allan Wainwright, CMA, for their accounting needs. We would like to thank Allan for all his support and expertise in maintaining the financial affairs of MCCA.

As this completes my second, two-year term as Secretary/Treasurer, I would like to thank the Finance Committee and staff for their hard work, great decision making and valuable input.

The Child Care Benefits Committee acts as an advisory committee to the MCCA Board of Directors. It is responsible for providing background information and making recommendations to the Board of Directors on the creation, management, coverage, and plan review for all MCCA insurance programs. These programs include:

- MCCA Group Benefit Plan, Health Source Plus
- MCCA Liability Plan, Morris Insurance Brokers
- MCCA Directors & Officers Liability Insurance, Morris Insurance Brokers

The Child Care Benefits Committee continues to meet and collaborate with our HSP partners Rob Carducci (Partner/Senior Benefits Consultant), Allison Lyall (Account Manager/Client Service), and Steve Mansbridge (Senior Benefits Consultant).

Formal committee meetings are held a minimum of three times per year for plan review. As in previous years, the committee remains vigilant to the goals of providing our membership a comprehensive plan that is affordable and transparent to those who use it.

In 2019, the plan saw a 3.6% overall DECREASE. In general, the plan is running predictably and in a reasonable manner.

Dave Morris and Brian Kelly from Morris Insurance continue to be supportive, knowledgeable, and active in their role as the liability insurance providers. Morris Insurance reports there are 402 centres and 350 FCCPs using the liability insurance, and 343 centres using the Directors & Officers liability at the end of 2019. Liability insurance for family child care providers saw an increase in their premium of \$15.00, noting that there has not been any increases since 2012. In October 2019, there was a \$10.00 increase per centre for D & O premiums, again the last increase being in 2012. Also effective October 2019, monthly insurance reports (for centres) switched from attendance based reporting to licensed space reporting.

Our committee continues to work hard on behalf of the membership ensuring quality programs at reasonable rates. Thank you to all of the committee members for bringing your passion and dedication to the Child Care Benefits Committee. It's a room full of talent!

The Public Policy and Professionalism Committee was kept very busy this year with a total of eight meetings along with a provincial and federal election, all held in 2019. Early in the year, we presented recommendations to Early Learning and Child Care Integrated Support Program and worked closely with them to improve the funding application process. Consistency and adequate funding for the Integrated Support Program still proves to be a challenge in the sector.

In January, the committee finalized a petition calling on the Provincial Government to recognize the importance of early learning and child care and to increase funding for not for profit licensed child care programs. This petition was a resounding success, with over 26,000 signatures from parents,



staff, and other concerned citizens. The Petition was read daily by the opposition party during question period at the Legislature. To keep the momentum going the committee recommended a Media Campaign. A graphic was created, #support26K, and buttons, a poster and window cling were distributed to all member centres. Lawn signs and T-shirts were also created and purchased at a nominal rate.

Once the provincial election was called, MCCA organized a walk in Assiniboine Park to again draw attention to the need for support in Early Childhood Education. The walk, which was held on August 20, had an approximate attendance of 2,200 people. All political parties were given an opportunity to speak, as well as a parent, an Early Childhood Educator and our MCCA President. This walk created a true sense of unity within the sector and some strong media attention. As a result of this, MCCA was asked to be a part of election coverage on both CBC and CTV.

In September the committee met with Rob Altemeyer who gave us some good insight into lobbying strategies. This meeting gave the committee much to consider and to decide what our next steps

should be. We have created a revised template for centres to use when they send out letters to their MLAs and our recommendations to the government have been simplified to state, "Provide adequate funding for a high quality early learning and childcare system." MCCA has joined the Manitoba Chamber of Commerce which will assist us in networking with and educating other organizations. The Committee also agreed that a united message for focus needs to be delivered. We agreed that the message would be "Reliable Early Learning and Child Care is essential in Manitoba".

Committee members continue to meet with government representatives of both the opposition and existing government, ELCC and local MLAs. 2020 will find us still busy as we work toward developing two video resources; the first will be profiling the importance of early learning and child care in MB. The second will promote MCCA and its work.

The MCCA School Age Committee is made up of Early Childhood Educators (ECE) and Child Care Assistants (CCA) who work within school age programs in the child care field and are members of the Manitoba Child Care Association (MCCA). This past year we said farewell to some long time members who left for a variety of reasons including retirement, maternity leave, and transitioning to other MCCA committees. We also welcomed several new members who want to share their knowledge and excitement for school age child care.

Our meetings are a time to network, gain support from other professionals, and learn about current issues related to school age child care. Some examples of topics discussed are collaboration with the school we are housed in; the transition of grade five and six children out of child care; and different ways to understand the challenging behaviours presented by some children. We meet a minimum of eight times a year, typically on the third Wednesday of the month (excluding May). Our primary meeting location is at the MCCA office, but this past year we also met at Fort Gary Child Care and at Voyageur In-School Program.

The annual School Age Resource Evening took place on November 7, 2019 at the Victoria Inn. There were four different topics on the agenda that evening: Risky Play in School Age, presented by Melinda Walden; Jennifer Waytiuk, shared her knowledge on the Circle of Security; Suzanna Otte collaborated with Mariella Carr and provided information on the process they go through in preparing for summer programming; and Brenda Still and Giovanna Rossing explored the idea of Schemas in School Age Child Care. The evening was a sell out with over 80 educators in attendance.

This past year the School Age Committee purchased two complete kits from Breakout EDU, a company that has created resources for educators to create challenges for their learners similar to escape rooms, but utilizing programmable locks. The intension for these lock boxes is for school age programs to borrow this resource to use use in their own centres. In Ocotber 2019, Suzanne Otte and Brenda Still facilitated a MCCA workshop on this educational tool, leading up to the release of this resource to MCCA members. The workshop was well attended and another similar workshop is planned for the future.

I want to thank each member of the School Age Committee for their commitment and passion to school age children.


