EXECUTIVE DIRECTOR'S & PRESIDENT'S REPORT

Jodie Kehl, Executive Director & Lynda Raible, President

Just when we thought we had moved passed all things pandemic, 2022 came flying in. The start of this year further exhausted our early learning and child care (ELCC) sector as illness continued to ravage through our environments with heightened cases of Omicron and then as the year ended, unprecedented cases of RSV (Respiratory Syncytial Virus) and influenza. Have we not endured enough?

And yet, so many truly spectacular things also occurred in 2022, which rekindled our connections with one another, reignited our passion for our profession and allowed us to move towards "normalcy".

Investments Into Early Learning and Child Care

As we progressed through the year, there were many reasons for optimism as we observed monumental investments into the "system" and the sector under the Canada-Manitoba Canadawide ELCC Agreement:

- "A one-time investment in the early childhood workforce of more than \$19 million to begin offering targeted support for the recruitment and retention of qualified staff for the early learning sector" – from this funding ensued the Wage Bridge Grant, Savings Investment Benefit, Retirement Enhancement Benefit
- \$37 million to support the implementation of the Wage Grid and Operating Grant Increases
- \$8.1 million allocated to fund 3100 spaces (previously unfunded) and operating grants to School-Age spaces

Were all investments welcomed and supportive of system building? Ummm, no not all (ahem, enter Subsidy Advance). However, what became increasingly clear is the enormous potential that the \$1.2 billion within the Canada-wide agreement can have on building an accessible, affordable, inclusive, high-quality early learning system in Manitoba.

With the reconvening of the Ministers Consultation Table in 2022, MCCA is cautiously optimistic that as future negotiations (for the remaining years of the agreement) and upcoming investments will be supportive of the necessary elements of building this Manitoba-made system for children, families and Educators.

The incredible work of MCCA in 2022!

January: MCCA hit the road running in January advocating for the health and safety of Early Childhood Educators as Omicron was ever rising and prevalent in our communities. Our messages were clear, lobbying for support, respect and support for the sector. And we asked hard questions to media and the policy makers "...I don't know if it's the lack of respect for a femaledominated workforce or simply the inability to understand how critical child care is, but I have to ask why are ECEs continuing to be overlooked, 24 months later?" (Jodie Kehl, CJOB, January 5, 2022). In mid-January, MCCA received notification ahead of the public announcement - ELCC was moving to a newly formed Ministry – Education and Early Childhood Learning. MCCA quicky sent off recommendations to the appointed Minister, Wayne Ewasko, on its position statement on the Integration of ELCC and Education.

MCCA continued with a new social media campaign entitled #MembershipMatters. It was an opportunity for MCCA members to highlight why belonging to a professional association is important to them.

February: In February, MCCA was invited to two significant announcements by the Province of Manitoba and Government of Canada. The first was the subsidy eligibility expansion (and the infamous Subsidy Advance). It was an honour to attend this event with both Premier Stefanson as well as Prime Minister Trudeau. The second was specific supports to the workforce. MCCA shared the stage with Minister Ewasko and addressed the long-awaited investments into the sector. ¹

MCCA welcomed their new Finance and Accounting Manager, Mandeep Sharma in this month. He has been a very appreciated addition to our team.

March: On March 1, 2022, MCCA gathered stakeholders from across the province to participate in a one-day session to develop the key strategies in building a high-quality ELCC system in Manitoba. This work would set the foundation for the future Roadmap released later in the year.

As the mask mandate was lifted in Manitoba (due to the pandemic), ELCC facilities had to begin to adjust to new practices. MCCA had the opportunity to speak to several media outlets on how this would impact children, families and ECEs.

MCCA made several presentations during the spring to ECE students on the topic of advocacy and the ELCC agreements.

April: MCCA was invited to the Provincial Budget lock up ahead of the Province of Manitoba announcing its 2022 budget. MCCA circulated a media release anticipating increase to operating funding adoption of MCCA's Market Competitive Salary Guideline Scale 2022-23, improved accessibility for children with additional support needs and increased spaces to meet the growing needs of Manitoba families.

The 2021 Awards Winners had the opportunity to meet with Minister Ewasko, Minister of Education and Early Childhood Learning, for the signing of the proclamation. They had the opportunity to spend over an hour talking to the Minister, sharing their "stories"

(CJOB) and Doug Wolitarsky (Winnipeg Blue Bombers). MCCA was on CTV Morning Winnipeg to spread the news about Week of the ECE.

May: MCCA was delighted to hold its 44th Annual Provincial Conference, *Reignite Your Passion*, in person after a three-year hiatus! We welcomed Keynote Speakers, Kevin Chief and David Falk. The energy and passion throughout the conference was undeniable. A very special part of conference is always the Annual Awards Banquet and this year was no exception.

June: On June 1, 2022, MCCA released its Roadmap to a Quality Early Learning and Child Care System in Manitoba. This document outlines how all levels of government, advocates, academics, researchers, the sector and stakeholders) can collectively realize a comprehensive, high-quality ELCC system for Manitoba's children, families and communities. It was developed under the



guidance and expertise of Jane Beach, as lead researcher.

MCCA was proud to represent its members in Ottawa in June, attending national advocacy meetings and a child care symposium with colleagues from across the country.

As we continued to return to in-person meetings, MCCA was thrilled to reunite the Pedagogical Leaders of Community of Practice – it had been 840 days since the last gathering.



July: In between summer holidays, MCCA held webinars on its Roadmap (for Directors, Family Child Care Providers and frontline ECEs), as well as one on the Market Competitive Salary Guideline Scale 2022-23.

August: August marked the 1-year anniversary since Manitoba signed its Canada-Wide ELCC Agreement. MCCA spoke to media about the steps taken and the critical work still required to build the system.

September: The School-Age Committee started selling their amazing "School-Age is All the Rage" t-shirts this month.

The 21st Directors Conference welcomed back Directors from across the province, including 38 new attendees, in Brandon, MB. Speakers, Chris Downey and David Falk, were captivating and informative. We took a trip back to the 1980's for the entertainment time. It was evident that leaders from across Manitoba, celebrated this opportunity to network, engage and learn!

October: The MCCA Ethics Committee held their annual retreat in October. This is an opportunity for the committee

to reconnect and plan for the upcoming year, reflecting on professional development that advances integrity of the ELCC field through ethical practice.

MCCA's newest committee, the Governance Support Committee, held it inaugural meeting this month.

And the Norman Region gathered for a professional development event with Shannon Gander entitled, *Recharge Your Body to Reset Your Mind*.

November: MCCA was invited to sit on the Joint Officials' Implementation Committee. Under the Canada-Manitoba ELCC Agreement, this committee has been established to allow Manitoba to meet with Canada to discuss the progress of the current Action Plan.

The School Age Committee hosted it annual School Age Resource Evening and welcomed over 60 participants. They spent their time networking and engaging in professional development on various School Age topics. MCCA's Central Region held a workshop in Portage la Prairie called We'll Sing a Song, and You'll Sing a Song Together, presented by Michele Grant and Melanie Glaser.

And finally, MCCA joined other community partners at the 14th Annual Gala and Fundraiser for the Provincial Council of Women of Manitoba.

December: At the final Directors' Lunch and Learn of 2022, MCCA welcomed nearly 100 Executive and Assistant Directors to listen to Minister Ewasko and Assistant Deputy Minister Sarah Whiteford with updates from the province.

It was a historic day in December when federal Minister of Families, Children and Social Development of Canada tabled Bill C-35 (An Act Respecting Early Learning and Child Care) in the House of Commons. The tabling of the bill signals the federal government's commitment to legislate and, essentially, protect ELCC and its current agreements with the provinces and territories.

As always, MCCA's members are the driving force behind the incredible work of the Association. Decisions, direction, professional development events, resources and actions are guided with our members in mind. We are growing in members and this strong commitment to early learning and child care and our professional association will continue to set us all up for success. Thank you to each and every one of you.

Our tremendous Provincial Board of Directors, Regional Branch persons, committee members and volunteers are the glue that keep all of this going. Thank you to you, all. It's a good time to be an Early Childhood Educator!

Another year has come to a close and we reflect on the past year's financial activities for MCCA. As of December 31, 2022 MCCA realized an unaudited surplus of \$51,059. MCCA will allocate this surplus across the following fund accounts: Building, Insurance and Project; which are all for future projects.

MCCA has a current membership of 4,191, a steady increase over the years. MCCA continued to hold true to their mission of to advocate for a quality system of child care, to advance early learning and child care as a profession and provide service to its members. They met this by advocating and working with government, providing high quality and relevant workshops and conferences, providing resources, communicating, listening and supporting its membership.

Revenue

Membership fees represents 57% of revenue with an increase of \$24,423 from the prior year. Membership Services represents 38% of revenue with an overall increase of \$118,009 from the prior year. Online Board Governance saw a significant decrease this year due to a grant received in 2021 for the translation of the online tool. The Director's Conference and Annual Conferences were in person this year for the first time since the pandemic and therefore saw big increases in revenue which are more reflective of prepandemic levels. The annual conferences netted a

profit of \$34,212! Miscellaneous revenue rounds out the remaining 5% - which includes: promotional items, donations, interest, Child Care Bridges advertising, etc.

Expenses

Salaries Expense increased this year by \$109,506 due to a full year of expenses for the Program Services Administrator and the hiring of a full-time Finance & Accounting Manager. In addition, the variance is related to the reallocation of accounting service expenses to salary expense. The prior year did not have a full year of these expenses.

Desk Top Publishing - Membership saw a decrease in expenses due to an increase in expenses in 2021 for the HR Guide and forms. There were some miscellaneous office equipment purchased during the year.

Fund Accounts

The Project Fund was used for:


- 1) An independent infrastructure review by People First ~ \$10,000,
- 2) Development of the 'Road Map to a Quality Early Learning and Child Care System in Manitoba' document~ \$19,000,
- 3) Development of the Market Competitive Salary Scale and Webinar ~ \$6,300.

The finance committee took on the task of reviewing the auditors for MCCA. We solicited a number of companies to put in an RFP. After interviews and reference checks, it was decided to leave Meyers, Norris, Penny after many years and go with The Exchange Group. This change will provide fresh 'eyes' on our finances as well as a cheaper bill!

We would like to thank the Finance Committee and staff for their hard work, great decision making and valuable input.

The past year has seen a gradual return towards some of the 'normal' activities we have all been missing during COVID-19 such as family fun days, fundraising events and other social activities. Child care centres and family child care providers continue to provide the highest quality child care in the country despite the many obstacles faced on a daily basis.

The MCCA insurance program provider (Aviva Insurance Company of Canada) continues to provide industry leading coverage, premium stability and excellent claim service. The past year has seen some significant claims (property and liability) and we are pleased with the way the company has handled these delicate situations. A designated team of Aviva adjusters was formed in fall 2022 to handle all MCCA claims which we hope will further streamline the process and ensure that service levels remain top priority for the program.

At present, enrollment numbers are as follows:

- 407 Centres (many of these have multiple locations which when taken into consideration, brings the total number of insured locations to 564)
- 344 Centres who carry Directors & Officers (D&O) Liability
- 335 Licensed family child care providers

We strongly urge all centres to purchase Directors and Officers (D&O) Liability in addition to your contents and general liability coverage. This affordable coverage provides board members with protection and peace of mind. If you are interested in adding or discussing this coverage, please give our office a call.

We provided an article on the benefits of building with Lego and the power of a fort. We included easy science experiments and schemas in science and construction play. "What's the Risk with Construction" was an invitation to our readers to incorporate more tools, materials, and loose parts into play and say "yes" to construction and the risk that goes with it.

The Fall issue was geared to "Technology in the Early Years". We offered advice on ways to prevent a personal privacy breach. We educated the readers about the technology used in school age programs, documenting using technology to document learning and shared some tips and tricks for using technology. Finally, we learned about the impact of technology on our brain through our mixed relationship with technology.

Our final theme and issue of Bridges in 2022 was "Growing our Knowledge". What is the Reciprocity of Mentorship? How do you navigate your classification? What is our path to child care? We shared 10 ways to advance professional development in early childhood education. Also through the MCCA Ethics workshops we looked at ways to "walk the talk" through our journey of personal and professional growth.

The work of this committee during the past year provided input to ELCC on the Provincial budget, the Provincial Canada Wide Agreement, (previous years recommendations for recruitment and retention strategies of a wage enhancement for child care staff and/or a onetime increase to the pension was part of the 2022 initiatives received by the sector). Ongoing recommendations to the Minister's Consultation Table and finally the importance of clear and timely communication to the sector specifically when it comes to grant initiatives presented through the Provincial Canada Wide agreements.

The committee along with the Board of Directors provided input to ELCC on the Subsidy Advance Surplus disbursement options to programs. Once again we asked for clear communication from ELCC with respect to these funds.
